## House History - 42 Fuhr Street, Tavistock



Plan 307 - Lot 103, West Side of Fuhr Street

Construction date of the house is believed to be circa 1901

Property records related to 42 Fuhr Street date back to when this property was part of Lot 36 in the 13th Concession of East Zorra. The first record was a Patent - a grant of land from the Crown - dated 1836 of the entire lot to Anson H. Groul (could be Grout as the handwriting is difficult to read). Groul started selling off small parcels of land in 1840 to various individuals including George Beyer, Henry Schaefer, Alexander Mitchell and William B. Hendershot. There are several recorded transactions regarding the railroad.

The Fuhr name, specifically Henry Fuhr, first appears in the records in 1867 and then appears several times in the years following both as seller and buyer. The many transactions of varying size lots makes it very difficult to track this particular lot, now known as Lot 103 West Side of Fuhr, during the very early years.

Events and transactions start coming more into focus in 1908 with records showing:

Without question, many of these names have a well-deserved place in the history of Tavistock.

From the Fuhr family we have Fuhr Street.

Edward A. Roth was well-known and well-respected in Tavistock having served as Clerk and Treasurer for the Village of Tavistock, Secretary of the Tavistock Public Utilities Commission, Secretary of both the School Board and Library Board and President of the Tavistock Arena Company Ltd.

James V. Field was the son of James G. Field, founder of the woollen mill that employed hundreds of local people during its long operation. James V. worked for a period as an agent for the CPR before taking over the operations of the JG Field & Co. Ltd. He continued in that role until 1953.

George K. Brown had printer's ink in his blood ... in this case Tavistock Gazette ink. George took over as publisher of the paper in 1929: entered into partnership with his son, K. Hartford Brown, in 1939: and in 1958 relinquished his interest in the newspaper.

Ken Sommers, who bought the property at 42 Fuhr in 1964, grew up just around the corner on Hope Street. Ken's dad, Wes Sommers, started a generator sales and service company at the Hope Street property. The family business grew such that Sommers Motor Generator Sales Ltd. served all of North America before it was sold in 2016.

No doubt over the years many a deal was done and many a story was told around the kitchen table at 42 Fuhr.
